Team Roping: Taking 50 total team roping horses. \$10,000 purse. Roping will be a #12.5 slide, no header under a triad #4+ and no heeler under a triad #5+. Each horse will draw 4 partners. Roping will be progressive after one. 1 rider can ride 2 horses (head or heel). **WSTR Rules/DRESS CODE IN EFFECT.** WSTR/USTRC card to rope. All horses must go through the sale before prize money is given, no shows will be \$350 per horse.

Preferred Performance Session: Limited Session. Only horses in the Preferred Performance Session will be allowed to Demo; Reining Work - Herd Work - Box & Fence - Heading - Heeling; You're not required to do all events, just show in areas of proficiency. Includes the Team Roping session.

Cow Dog Session: They will sell first Saturday morning Feb 7 @ 9:00 am, they will be demonstrated on Friday Feb 6 @ 10:00 am. 8% commission, \$175 entry fee per head, \$175 No sale fee per head, \$50 demonstration fee per head. You can use this same form for your cow dog entry.

(No lab) All catalog fees must be paid at time of entry. Sale order is determined by draw. Sale proceeds will be held until all necessary paperwork is in the LHS office, otherwise settlement will be made on Friday after the sale. All guarantees are between the seller & buyer. All horses are presumed to be sound which means sound of limb and wind with all vices declared including cribbing, weaving and all other undesirable traits. LHS is strictly an agent, but we require full disclosure of all faults/defects. All horses that sell on a registration application or bred mares without breeders' certificates sell without no warranty or guarantee on papers, they sell as-is. LHS is not responsible for sickness/accident. Emailed confirmation letters will go out 3 weeks before the sale and catalogs will be mailed to sellers 2 weeks prior to the sale. It is your responsibility to get your horse to and from the sale ring at its designated time. Bring water/feed buckets. Stalls are assigned. 1 bag shavings provided (\$15.00 per bag). Horses sell in catalog order. No alley trading or transit horses. **••Only Horses in the Team Roping Session and in the Preferred Performance Session will be allowed to demo on Friday Feb. 6 - Demo features: Reining Work – Herd Work – Box & Fence – Heading – Heeling; You're not required to do all events, just show in areas of proficiency.**
